



Rental Agreement

Article 1. Age,

1. The lessor applies a minimum age for tenants and directors of 18 years. Legitimation is mandatory.

Article 2. Sailing, rules of conduct and sailing area,

1. The renter must use the rental boat as a good family man and good skipper and according to the destination.
2. The landlord provides the tenant with a map of the permitted sailing area. If the tenant wishes to deviate from this, permission from the lessor is required before the start of the rental period. Also deviating from the sailing route is at your own risk.
3. It is not permitted to sail on the Ems, the Dollard or the Wadden sea.
4. It is not permitted to sail a (predicted) wind force of 5 Beaufort or more. We will then cancel the reservation because it is not justified to sail out.
5. The tenant must adhere to the maximum number of people on the rental boat.
6. The renter must adhere to the inland navigation police regulations and the maximum sailing speeds in the sailing area.
7. The renter must adhere to the rules of the lessor regarding bridges, locks and other obstacles in the shipping area.
8. The renter must ensure that the driver of the rental boat is not under the influence of alcohol and/ or narcotics, if this is the case then we may collect you from the boat if it is not justified after our idea more or get complaints from the environment.
9. The tenant must hand in the rental boat neatly and cleanly to the lessor after the end of the rental period. If this is not the case, we will charge a € 30,- euro cleaning fee.
10. The renter rents the boat and the period stated on the invoice. If the renter stays away longer than known to the renter, € 60 euros will be charged and the costs for the group that must board later and can therefore be used for a shorter period. sail.
11. In the event of improper conduct or not following the instructions of the lessor, we have every right to remove you from the boat with anti-social behavior or the harassment/destruction of other people's belongings.
12. Pets are not allowed on board the rental boat.

Article 4. Deposit, damage and liability

1. The lessor ensures that the rental boat is in good condition before the start of the rental period.
2. The landlord provides adequate liability insurance and Casco insurance for the rental boat.
3. The renter has a deductible of EUR 500 for damage to or loss of the rental boat or damage caused to third parties. In the event of damage, the tenant must immediately pay the excess in cash to the landlord.
4. The renter must immediately report the loss of and / or damage to the rental boat and / or third parties to the lessor on telephone number 06-22873205.
5. In the event of damage due to gross negligence and / or arising outside the permitted sailing area, not only the deductible, but the full amount of the damage will be charged to the tenant.
6. The landlord is not liable for physical injury and / or damage to private property of the tenant.
7. The renter is not permitted to carry out repairs on the rental boat without the permission of the lessor.
